Digital Show Representative & Steward Reports

Friendly reminder that all Show Representative & Steward reports must now be submitted digitally. The paper version is no longer accepted, and all reports must be completed online within 15 days of the conclusion of the event. Please ensure your Show Representative or Steward submits the required report through the designated digital platform to ensure compliance and timely processing. Correcting Problem Reports Promptly

Once your event results are processed, you will receive a problem report by email outlining any issues that need attention. To help minimize fines, it is crucial to reach out directly to affected members and work with them to resolve missing documentation.

Show secretaries have a three-day window to correct errors, which will reduce fines for yourself and our members. The sliding scale for reduced fines is as follows:

- **AA & A Events** – With corrections, fines can be reduced to a minimum of \$100.
- **BB Events** – With corrections, fines can be reduced to a minimum of \$50.
- **B Level Events & lower** – Fines can be reduced based on the amount corrected.

Taking prompt action on your problem reports not only ensures accuracy but also helps avoid unnecessary penalties. Don't miss this opportunity to save money - check your problem report and make corrections within the designated timeframe listed in the email!
