**\*\*A horse's name may only be changed if it has been changed with a breed registry, and it has not competed in an NRHA show or been listed as the sire or dam on an offspring's competition license or nomination. For grade horses, only the second condition applies.**

**In-Office Processing & Fees:**

Thanks to the availability of online member tools to do nearly all member transactions, and to follow best practices for credit card security, changes have been made for how paperwork will be received by NRHA.

NRHA Nominations will not be accepted via email or fax. Additionally, faxes will not be accepted for *any* transaction.
