## Competition Organizer Survey for Economic Impact Study

The AHC has partnered with several sponsors to offer 15 incentive prizes, including:

## *Are ALL signatures required on the Medications Report Form?*

Yes, all signatures are required on the Medications Report Form.

## *When, where, and to whom does the Medications Report Form get turned in?*

The Medications Report Form must be turned in prior to competing. We understand those using the Medications Report Form to declare the use of Romifidine will potentially need to have a designated responsible party turn in the form to the show office due to the proximity of administration to competition time. The form still must be submitted prior to competition. Medications Report Forms are turned in to a designated representative in the Horse Show Office.
